This work is believed to have been included in the sale *Alte und neue Bilder* which was held by Adolph Weinmüller in Vienna on 8–9 July 1940.

Per the extant correspondence, Hildebrand Gurlitt acquired a half share of a Tischbein female portrait from the art dealer C. G. Boerner in Leipzig between December 1944 and October 1945. That painting, which was consigned to Boerner by one Frau Zahnow, was priced at 8,000 reichmarks; each half-share thus amounted to 4,000 reichmarks.
