Note:

This drawing was executed by Marguerite Gérard (1761–1837), the sister-in-law and pupil of Jean-Honoré Fragonard.

The first known owner of this drawing was the antiquarian Emmanuel Alfred Beurdeley (referred to by Lugt as Alfred Beurdeley II, 1847–1919), a descendent of the famous family of French cabinetry makers. A part of his collection, comprising eighteenth-century drawings, was sold in 1905. At that sale, this work was acquired by Jewish banker Pierre de Gunzbourg for the sum of 300 francs. During the occupation of France, the contents of the Gunzbourg's apartment was seized by the Dienststelle Westen. So far, no evidence could be found that this drawing was looted from the family's collection.
